### **Guidelines for Fund Distributions from The Mobile Touchdown Club:**

1. The recipient organization will be actively involved in making sport and athletic venues available to the youth of Mobile and Baldwin Counties.
2. The amount of the distributions will not exceed the operating surplus from the previous year. The timing of the distribution should coincide with the maximum earnings of the investments and collection of dues.
3. Only written applications will be considered. The form for those requests for funding will include the name of the organization, length of time in operation, the physical location of the organization and its activities, the amount of the request, the reason for the request, the number of youth that would be impacted if the request were granted, and the agreement to submit a follow up report on the results of the activity if the request is authorized at the end of the activity cycle.
4. The Executive Committee of the Mobile Touchdown Club will serve as the Distribution Committee for the Mobile Touchdown Club and determine the amounts to be distributed and to which organizations.
5. Funds will not be granted for personnel expenses.
6. Funds will not be granted to purchase or improve real estate.
7. Funds will be granted for the purchase of sports equipment or for scholarships to deserving young people to participate in sports related programs.
8. Grants will be awarded to primary providers, and not to secondary organizations on the behalf of another.
9. Distributions will be made solely to 501 C organizations.
10. These guidelines can be revised or overridden by 80% vote of the Board of Directors.
